



**HARRIS GEOSPATIAL SOLUTIONS, INC.**  
**HELIOS® TERMS OF SERVICE (“TOS”)**

**1. Acceptance of Terms; Changes**

The Site (defined below) is made available to User (defined below) by Harris Geospatial Solutions, Inc (“HGSI”) subject to User’s acceptance of the TOS and any applicable license agreement. HGSI is a subsidiary of Harris Corporation. When using any Services, User agrees that it is subject to any additional posted guidelines, rules, terms, and/or conditions applicable to such Services, which are hereby incorporated in the TOS by reference. The “Site” means the Helios API/network/web application and other products and services (collectively, the “Service”) provided by HGSI via <https://helios.earth/developers/> and <https://helios.earth/explore/login> (the “Site” or “Sites”). “User” means licensee, an evaluator of the Services, person or organization accessing the Site.

HGSI reserves the right to, from time to time, make changes to the TOS in its sole discretion, whether in whole or in part, for any reason. The most recent version of the TOS will always be posted to the Site. If HGSI does make any changes, HGSI will also update the Services on the Site and HGSI may provide User with other forms of notice as well. Changes to the TOS will become effective when HGSI posts the revised TOS to the Site. By continuing to interact with the Site following such changes, User is accepting and agreeing to be bound by the revised TOS. HGSI encourages User to review the Terms periodically to ensure that User understands its rights and obligations in connection with User’s use of the Site.

HGSI also reserves the right, at any time and from time to time, temporarily or permanently, in whole or in part, to: modify or discontinue the Site, with or without notice; charge fees in connection with the use of the Site; modify and/or waive any fees charged in connection with the Site; and offer opportunities to some or all Users of the Site. User agrees that neither HGSI nor any of its affiliates, subsidiaries, or operating divisions (collectively, “Affiliated Entities”) shall be liable to User or to any third party for any modification, suspension, or discontinuance of the Site, in whole or in part, or of any Service, content, feature, or product offered through the Site. User’s continued use of the Site after such changes will indicate User’s acceptance of those changes.

**2. Description of the Services**

HGSI may provide Users of the Site with access to certain content and services related to HGSI’s online services including: (i) services including but not limited to weather, traffic, environment imaging and monitoring functionalities and (ii) content such as audio and/or video clips, graphics, images, text, data, postings, messages, and other similar content/services; (collectively, the “Services”).

**DISCLAIMER: The Services involving weather imaging, monitoring, or similar functionality are based on an emerging technology advisory service designed to provide decision-makers with**



insight and vigilance. However, it is important to note that current site conditions may differ from displayed images due to a variety of reasons, such as rapidly changing weather patterns, image update frequency, and optical distortion. User expressly acknowledges and agrees that such images are exclusively intended for use as a supplemental product to improve situational awareness. IT IS IMPERATIVE THAT USERS DO NOT RELY ON WEATHER IMAGING OR MONITORING FUNCTIONALITY AVAILABLE THROUGH THE SITE AS A WARNING OR ALARM VEHICLE UNDER ANY CIRCUMSTANCES. The National Weather Service (“NWS”) is the official weather warning authority for the citizens of the United States of America.

### **3. Information Submitted Through the Site**

Any submission of information on or through the Site is governed by HGSI’s Website Privacy Policy <http://www.HGSIinc.com/company/Pages/Privacy-Policy.aspx> (the “Policy”), which is hereby incorporated into the TOS by reference. User represents and warrants that any information User provides in connection with User’s use of the Site is and shall remain true, accurate, and complete, and that User will maintain and update such information regularly. User further acknowledges and agrees that if any information User provides is false, inaccurate, obsolete, incomplete, or otherwise violates this TOS, HGSI may terminate User’s use of the Site and/or any Service, content, feature, or product offered through the Site.

### **4. Rules of Conduct**

User must respect the rights and dignity of others and comply with applicable laws, rules, and regulations at all times when using the Site. User’s use of the Site is conditioned on compliance with the TOS, including the rules set forth in this Section 7 (the “Rules of Conduct”). Failure to adhere to the Rules of Conduct may result in termination of User’s access to the Site.

By accessing the Site, User agrees that User will not:

- a) Post, transmit, or otherwise make available through or in connection with the Site:

  - 3) Any virus, worm, Trojan horse, Easter egg, time bomb, spyware, or other computer code, file, or program that is harmful or invasive or may damage or hijack the operation of, or to monitor the use of, any hardware, software, or equipment.
  - 4) Any unsolicited or unauthorized advertising, promotional material, "junk mail," "spam," "chain letter," "pyramid scheme," or investment opportunity, or any other form of solicitation.
  - 5) Any material, non-public information about a company without the proper authorization to do so.



- b) Use the Site for any fraudulent or unlawful purpose.
- c) Use the Site to defame, abuse, harass, stalk, threaten, or otherwise violate the legal rights of others (including privacy rights or rights of publicity), or harvest or collect Personal Information (as defined in the Policy) <http://www.HGSIinc.com/company/Pages/Privacy-Policy.aspx> about other users of the Site with proper authorization to do so.
- d) Impersonate any individual or entity, falsely state or otherwise misrepresent User's affiliation with any person or entity, or expressly claim or imply that HGSI endorses any statements User makes.
- e) Interfere with or disrupt the operation of the Site or the servers or networks used to make the Site available, or violate any requirements, procedures, policies, or regulations of such servers or networks.
- f) Restrict or inhibit any other person from using the Site.
- g) Use the Site to advertise or offer to sell or buy any goods or services without HGSI's express prior written consent.
- h) Reproduce, duplicate, copy, sell, resell, or otherwise exploit for any commercial purposes any portion of, use of, or access to the Site.
- i) Modify, adapt, translate, reverse engineer, decompile, or disassemble any portion of the Site.
- j) Remove any copyright, trademark, or other proprietary rights notice from the Site or related services or materials.
- k) Frame or mirror any part of the Site without HGSI's express prior written consent.
- l) Create a database by systematically downloading and storing Site content.
- m) Use any robot, spider, site search/retrieval application, or other manual or automatic device to retrieve, index, "scrape," "data mine," or in any way gather Site content or reproduce or circumvent the navigational structure or presentation of the Site without HGSI's express prior written consent.

Additionally, User acknowledges and agrees that User (and not HGSI) is responsible for: (i) obtaining and maintaining all telecommunications, broadband, and computer hardware, equipment, and services needed to access and use the Site; and (ii) paying all charges related thereto.

## **5. Products, Content, and Specifications**

Descriptions and images of, and references to, third-party products or services available in connection with the Site do not imply HGSI's endorsement of such third-party products or services. All descriptions, images, references, features, content, specifications, products, and prices of products and services described or depicted on this Site are subject to change at any time, with or without prior notice. Certain measurements and similar descriptions are approximate and are provided for convenience purposes only.

HGSI reserves the right, with or without prior notice, to: (i) discontinue or limit the available quantity of any product or service; (ii) honor or impose conditions on the honoring of any



coupon, coupon code, promotional code, or other similar promotion; and/or (iii) refuse to provide any user with any product or service.

## **6. Accuracy of Information**

HGSI attempts to ensure that information on this Site is complete, accurate, and current. Despite its efforts, the information on this Site may occasionally be inaccurate, incomplete, or out-of-date. HGSI makes no representation as to the accuracy or correctness of any information on this Site.

## **7. Registration; User IDs and Passwords**

User may be required to register with HGSI in order to obtain a User ID and password necessary to access certain Services or areas of the Site. With respect to any such registration, HGSI may refuse to grant User and User may not use any User ID that: (i) is already being used by someone else; (ii) may be construed as impersonating another person; (iii) belongs to another person; (iv) personally identifies User; (v) violates the intellectual property or other rights of any person; (vi) is offensive; or (vii) HGSI rejects for any other reason in its sole discretion.

HGSI does not represent or warrant that the Site or any part thereof is appropriate or available for use in any particular jurisdiction other than the U.S.A. In choosing to access the Site, User does so on User's own initiative and at User's own risk, and User is responsible for complying with all local laws, rules, and regulations. The TOS shall be governed by and construed in accordance with the laws of the State of Florida, U.S.A., without regard to its principles of conflicts of law. In the event of any dispute or claim



arising out of or in any way related to the Site, the Services, and/or the TOS, you agree to exclusive jurisdiction of the federal and state courts located in the Middle District of Florida, and User expressly waives any jurisdictional, venue, or inconvenient forum objections to such courts.

## **10. License**

For purposes of clarity, User retains ownership of any information, content, and/or materials User submits through the Site (each, a "Submission"). However, please note that HGSI needs certain rights to User's Submissions to be able to make them available on the Site. As such, User hereby grants to HGSI, the Affiliated Entities, and their respective service providers and designees a worldwide, non-exclusive, transferable, sublicensable (through multiple tiers), royalty-free, perpetual, irrevocable right and license, without compensation to User, to: use, reproduce, distribute, adapt (e.g., edit, modify, translate, reformat, etc.), create derivative works of, transmit, publicly display, and publicly perform such Submission, in any media now known or hereafter developed. This license is non-exclusive (so User can license its Submissions to others), worldwide (as the internet is global in its reach), fully-paid up and royalty-free (so that HGSI does not have to pay User for posting its Submissions), sublicensable through multiple tiers (so that HGSI can use its service providers and subcontractors to provide Services).

For each Submission, User represents and warrants that: (i) User has all rights necessary for it to grant the licenses discussed in this section of the TOS; and (ii) both the Submission and User's provision thereof to and through the Site otherwise comply with this TOS and all applicable laws, rules, and regulations. User further irrevocably waives any "moral rights" or other rights with respect to attribution of authorship or integrity of materials regarding each Submission that User may have under any applicable law under any legal theory. HGSI requests this waiver to help ensure that HGSI has all the rights HGSI may need to provide the Services available through the Site.

## **11. Monitoring**

HGSI, the Affiliated Entities, and their respective employees, officers, directors, shareholders, affiliates, agents, representatives, licensors, suppliers, and service providers (collectively, the "Related Parties") reserve the right, but do not assume the responsibility, to review, delete, edit, or otherwise alter all Submissions in any manner it deems fit. HGSI may remove any Submissions that HGSI deems, in its sole discretion, to be inappropriate, offensive, or HGSI also reserves the right to access, read, preserve, and disclose any Submissions that HGSI reasonably believes is necessary to (i) satisfy any applicable law, regulation, legal process, or governmental request; (ii) enforce this TOS, including investigations of potential violations hereof; (iii) detect, prevent, or otherwise address fraud, security, or technical issues; (iv) respond to support requests; (v) protect the rights, property, or safety of HGSI, the Affiliated Entities, the Related Parties, users of the Site, and/or the general public; or (vi) achieve any other goal or purpose.



User expressly acknowledges and agrees that HGSI will not be liable or responsible for the exercise or non-exercise of its rights under the TOS.

## **12. Proprietary Rights**

The information and materials made available through the Site, including the Services: (i) are and shall remain the property of HGSI, the Affiliated Entities, and/or the Related Parties (as applicable); and (ii) are protected by copyright, trademark, patent, and/or other proprietary rights and laws. Except as expressly authorized in prior written form by the holder of the relevant proprietary rights, User agrees not to copy, reproduce, modify, rent, lease, loan, sell, license, decompile, reverse engineer, publish, distribute, or create derivative works based on (whether in whole or in part), all or any part of the Site or any materials made available through the Site. All trademarks and service marks on the Site not owned by HGSI are the property of their respective owners. The trade names, trademarks, and service marks owned by HGSI, the Affiliated Entities, and/or the Related Parties, whether registered or unregistered, may not be used in connection with any product or service that is not owned by HGSI, in any manner that is likely to cause confusion. Accordingly, User expressly acknowledges and agrees that HGSI, the Affiliated Entities, and the Related Parties: (i) are not responsible for the availability of such third-party websites or services (or for any links from such websites or services to the Site); (ii) do not endorse and are not responsible or liable for any content, advertising, products, or other materials available on or through such third-party websites or services; and (iii) shall not be liable for any loss or damages incurred in connection therewith.

USER AGREES THAT USER'S USE OF THIRD PARTY WEBSITES AND RESOURCES (INCLUDING ANY CONTENT, INFORMATION, DATA, ADVERTISING, PRODUCTS, OR OTHER MATERIALS AVAILABLE ON OR THROUGH SUCH WEBSITES AND RESOURCES) IS AT USER'S OWN RISK AND IS SUBJECT TO THE TERMS AND CONDITIONS OF USE APPLICABLE TO SUCH WEBSITES AND RESOURCES.

TO THE FULLEST EXTENT PERMISSIBLE UNDER APPLICABLE LAW AND WITHOUT LIMITING THE FOREGOING, HGSI, THE AFFILIATED ENTITIES, AND THE RELATED PARTIES SPECIFICALLY DISCLAIM ANY AND ALL WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, QUALITY OF INFORMATION, QUIET ENJOYMENT, NON-INFRINGEMENT, AND TITLE.
